

#### **PRIVACY STATEMENT**

#### General

JNRE Legal respects your personal data and ensures that the personal information you provide to JNRE Legal or that JNRE Legal obtains in any other way is treated confidentially. Personal data refers to any information about a person. Data that indirectly says something about someone is also personal data. With the following, JNRE Legal implements the information obligation laid down in the General Data Protection Regulation (AVG) to the data subject(s) whose personal data JNRE Legal processes.

## Processing personal data

JNRE Legal processes personal data to be able to offer services, improve services and communicate personally with you as a data subject. JNRE Legal may engage a third party to evaluate its services. You, the data subject, make the choice to participate in this and to leave personal data for this purpose. You can also sign up to receive a newsletter or other forms of communication from JNRE Legal.

JNRE Legal processes the (types or categories of) personal data listed below for the provision of services or provided by the person concerned on their own initiative:

- a. first and last name;
- b. address details;
- c. telephone number;
- d. e-mail address;
- e. data about your activities on the JNRE Legal website (<u>www.jnre.nl</u>).

JNRE Legal processes these personal data because they have been provided by you as a data subject on your own initiative, have been obtained in the context of the provision of services, have been made known by third parties (including counterparties), or have become known through public sources.

JNRE Legal does not intend the website and/or services to collect data on minors without parental consent. However, JNRE Legal cannot verify whether a visitor to <a href="www.jnre.nl">www.jnre.nl</a> is a minor. JNRE Legal therefore recommends that parents be involved in their children's online activities to avoid collecting data about children without parental consent. ## Basis and purpose of processing personal data

JNRE Legal processes the personal data referred to above exclusively based on the following grounds as referred to in Article 6 of the AVG and for the purposes specified thereafter:

# grounds:

a. legal obligation;

- b. performance of an agreement;
- c. consent obtained from data subject(s);
- d. legitimate interest;

#### purposes:

- e. provision of legal services, including performance of an agreement;
- f. conducting (legal) proceedings;
- g. collection of declarations;
- h. compliance with legal obligations;
- i. marketing and communication activities.

## Automated decision-making

JNRE Legal does not make decisions based on automated processing about matters that could (significantly) affect individuals. These are decisions that are made by computer programs or systems, without a person (e.g., an employee of JNRE Legal) in between.

## **Retention period**

JNRE Legal does not retain personal data being processed for longer than is necessary for the aforementioned purposes of data processing or is required under laws and regulations.

## Sharing personal data with third parties

JNRE Legal only shares your personal data with third parties to the extent necessary for the provision of services in accordance with the aforementioned purposes. This includes, for example, the deputization of the practice by another lawyer, the performance of an expertise survey or the engagement of another third party on behalf of and at the instruction of JNRE Legal, but also the provision of your personal data in connection with (legal) proceedings or correspondence with the other party.

In addition, JNRE Legal may provide personal data to a third party, such as a regulator or another body vested with public authority, insofar as there is a legal obligation to do so.

JNRE Legal shall conclude a processing agreement with the third party that processes your personal data on behalf of and at the instructions of JNRE Legal, as a result of which that third party is also obliged to comply with the AVG. Third parties engaged by JNRE Legal, which offer services as processors, shall themselves be responsible for compliance with the AVG for the (further) processing of your personal data. This could include an accountant, notary, other third party engaged for the purpose of a second opinion or expert report.

## Use of social (media) networks/ websites of third parties

The website(s) of JNRE Legal (<a href="www.jnre.nl">www.jnre.nl</a>) include buttons (also called buttons) and/or links to social (media) networks (such as LinkedIn) and third-party websites. JNRE Legal does not monitor and is not responsible for the processing of your personal data by and through such third parties. Use of such

media is therefore at your own risk. Before using those third-party services, it is advisable to read the privacy statement of those third parties.

#### Statistics and cookies

JNRE Legal maintains usage data of the website <u>www.jnre.nl</u> for statistical purposes. The personal data collected in this way are in principle anonymous and JNRE Legal will not sell them to third parties.

To increase the ease of use of the JNRE Legal website, JNRE Legal makes use of so-called 'cookies'. A cookie is a small text file that during your visit to the website of JNRE Legal is placed on, for example, your computer, tablet, or smartphone. JNRE Legal uses only technical and functional cookies and analytical cookies that do not invade your privacy. The cookies used by JNRE Legal are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and, for example, remember your preferences. They also allow JNRE Legal to optimize the website. You can refuse the use of these cookies at any time, although this may limit the functionality and ease of use of the website(s). You can opt out of cookies by setting your Internet browser to no longer store cookies. In addition, you can also delete any information previously stored through your browser's settings.

## Viewing, adjusting, or deleting data

You have the right to view, correct or delete your personal data. You also have the right to withdraw your possible consent to data processing or object to the processing of your personal data by JNRE Legal and you have the right to data portability. This means that you can submit a request to JNRE Legal to send the personal data that JNRE Legal holds about you in a computer file to you or another organization named by you.

A request for inspection, correction, restriction, opposition, transferability of data, deletion of your personal data or withdrawal of previously given consent, can be sent to info@jnre.nl or:

You will receive notice from JNRE Legal within four weeks of receiving your request. There may be circumstances in which JNRE Legal cannot or cannot fully comply with your request as a data subject. This could include the duty of confidentiality of lawyers and statutory retention periods.

To ensure that JNRE Legal provides the relevant personal data to the correct person based on your request, JNRE Legal will ask you to submit a copy of a valid passport, driver's license, or proof of identity with a protected passport photo and BSN number for verification purposes. JNRE Legal will only process requests that relate to your own personal data.
